## **Admission Procedure in Management Quota Seats of M.Pharm.**

Candidates who are interested to take admission in Management Quota seats in M.Pharm. course during session 2026-27 at ROFEL Shri G.M. Bilakhia College of Pharmacy should fill the “**Application Form for M.Pharm Admission**” available at college office on working days between 9.00 am to 4.00 pm. The applications should be submitted before the stipulated last date of application form submission. Applications submitted by Post/ Courier/ etc. will not accepted. The presence of candidate is compulsory on the date and time of admission counseling. No change in date of admission counseling shall be accepted. The date of admission counseling shall be posted on college website/ college notice board.

The candidates are advised to refer the website of Centralized State Admission Committee (ACPC): [www.acpc.gujarat.gov.in](http://www.acpc.gujarat.gov.in) for seats available and eligibility of admission on MQ seats and also website of college [www.rofelpharmacy.ac.in](http://www.rofelpharmacy.ac.in). for important dates and notice regarding management quota admission.

### **1. Filing Application Form for Management Quota Seats:**

Fill all the details asked in the Application Form and attach all requisite documents as asked for and ensure that all entries are correct. The last date shall be as notified separately on the website/ college notice board/ advertisement in newspapers. Such dates will be different for MQ and VQ rounds of admissions. The VQ round will be held only if seats remain vacant after ACPC round for ACPC-SQ seats. The candidates are advised to visit college website for information of such dates.

It is informed that the college can reject application OR cancel admission, if any false information provided in application form is detected even at a later stage. Incomplete application shall be rejected. All documents pertaining to the eligibility of admission shall be verified with original at the time of admission counseling.

### **2. Preparation of Inter-se-Merit:**

The “Inter-se-merit” will be prepared of all such applications received before the stipulated last date of submission on the basis of “ACPC Merit Rank” declared by ACPC and the seats will be offered on the basis of their preference mentioned in the form.

### **3. Important Dates of Management Quota Admission**

The candidates to whom admission is offered, has to deposit fees through UPI/ NEFT/ IMPS/ RTGS by next day. If the fee is not deposited within stipulated time, then their right of admission will be forfeited and the seats will be offered to the next waiting candidates on inter-se-merit.

The waitlisted candidates on the MQ Inter-se-merit list may be considered for Vacant Seats against Cancellation OR ACPC-State Quota Seats OR due to not-reporting if any.

**N.B.:** It is hereby informed that candidates with 55% aggregate in B.Pharm., who did not have PG CET merit rank or GPAT valid scores can also apply in vacant seats if any. They must contact the college office for the same.

### **4. Admission for Vacant Seats due to Cancellation and Not reporting if any:**

If the seats remain vacant after completion of online round of ACPC admission (SQ seats), then the applications to fill such vacant seats shall be invited from eligible candidates and the Vacant seats due to cancellation or non-reporting will be filled from inter-se-merit prepared from the applications received for such vacant round before the stipulated date.

The admission will be offered as per Inter-Se-Merit to fill the vacant seats if any. The last date for submission of applications for this phase will be intimated on college website/ College Notice Board at a later date. The actual number of the vacant seats to be filled shall be displayed on the date of VQ seat counseling.
